If there is a complaint about a particular licensee, needs to be put in writing. Will double-check that whatever is online is correct.

O'Baugh - Licensing changed for tattoo for career education when turned over to health department. Discussion of fee structure and laws at schools. Needs legislation to change fees.

- 2 MR. JACKSON: Good morning, my name is Adam Jackson.
- 3 I'm an assistant attorney general. I'm the hearing officer
- 4 today in the matter of Sasha Parnell, which is to be heard
- 5 before the Cosmetology Technical Advisory Committee.
- Today is Monday, September 25. If you'll please silence
- 7 your cell phones now. Is the respondent, Ms. Parnell, here?
- 8 If you could have a seat right here we'll have you identify
- 9 yourself, for the record, and then we'll have you have a seat
- 10 -- I'll let the -- I'll let madam court reporter tell you
- 11 where it will be easiest.
- 12 If you can please identify yourself, for the record.
- MS. PARNELL: I'm Sasha Parnell.
- 14 MR. JACKSON: And Ms. Parnell, are you represented by
- 15 counsel?
- MS. PARNELL: [shakes head from side to side.]
- MR. JACKSON: Verbally, say that, so she can hear it.
- MS. PARNELL: No, no.
- 19 MR. JACKSON: Okay, and did you receive a copy of the
- 20 order and notice of hearing to be here today?
- MS. PARNELL: Yes.
- MR. JACKSON: And are you ready to proceed?
- MS. PARNELL: Yes.
- 24 MR. JACKSON: If you could have a seat right over

- 1 there, next to this gentleman, I think she should be able to
- 2 hear you over there.
- 3 Counsel, if you could identify yourself for the record?
- 4 MR. THOMPSON: Charles Thompson, attorney, Arkansas
- 5 Department of Health.
- 6 MR. JACKSON: For the benefit of anyone present today
- 7 who may not have appeared in an administrative hearing, the
- 8 board will base its decision solely on the evidence presented.
- 9 This hearing is held under the Administrative Procedures
- 10 Act, which means that the strict rules of evidence do not
- 11 apply, and the parties will be given latitude in introducing
- 12 the evidence.
- 13 This is to promote a fair hearing and to provide the board
- 14 with adequate information to make a decision.
- To ensure the efficiency of the proceedings, I will grant
- 16 objections or caution parties only as necessary. If there is
- 17 anything that you have in your possession that you want the
- 18 board to consider, you must offer it into evidence here today.
- 19 All participants to the hearing should be aware that these
- 20 proceedings are subject to the Freedom of Information Act, and
- 21 as such, all parts of the hearings, including the
- 22 deliberations of the board, are open to the public.
- 23 It's important that all persons necessary to the hearing
- 24 are in the room during the hearing. If a party, or attorney

- 1 or board member needs to take a break please advise me, and
- 2 we'll do so.
- 3 Counsel, who are going to be your witnesses here today?
- 4 MR. THOMPSON: Kelli Kersey.
- 5 MR. JACKSON: And Ms. Parnell, do you have any
- 6 witnesses here today? Are you going to testify on your own
- 7 behalf, I'm assuming?
- 8 MS. PARNELL: Yes.
- 9 MR. JACKSON: Okay, if both of y'all can raise your
- 10 right hand, I'll get you sworn in.
- 11 [witnesses swore to tell the truth in these proceedings]
- 12 MR. JACKSON: Let the record reflect that both Ms.
- 13 Kersey and Ms. Parnell have been sworn in. Counsel, are there
- 14 any preliminary matters that need to be addressed?
- MR. THOMPSON: Yes, I'd like to enter into evidence
- 16 what needs to be marked as -- which I'll request to be marked
- 17 as Petitioner's Exhibit 1. And that is the notice of hearing.
- 18 MR. JACKSON: Has this been provided to the
- 19 respondent?
- 20 MR. THOMPSON: It was provided to her, hand delivery,
- 21 by Ms. Kersey. But I don't think she has a copy with her
- 22 today.
- 23 MR. JACKSON: Let's give her a copy of it first, and
- 24 let's make sure she has no objections.

- 1 MR. THOMPSON: And Exhibit 1 consists of the notice of
- 2 hearing, statement of -- I'm sorry -- the statement of fact,
- 3 notice of hearing, a document from Ms. Kersey noting her hand
- 4 delivery of the same to Ms. Parnell, and the finding of facts
- 5 and conclusions of law from the original hearing on July 23,
- 6 2019.
- 7 MR. JACKSON: Okay. Ms. Parnell, do you have any
- 8 objections to this being admitted?
- 9 MS. PARNELL: No sir.
- 10 MR. JACKSON: Seeing as there are no objections, it
- 11 shall be admitted. Counsel, do you want to publish it?
- 12 MR. THOMPSON: Please to the board members.
- 13 MR. JACKSON: It can be published. Ms. Parnell, do
- 14 you have anything -- any documents or anything that you want
- 15 admitted here this morning?
- MS. PARNELL: Unfortunately, no.
- 17 MR. JACKSON: How these proceedings will work,
- 18 generally speaking, is counsel for the department will call
- 19 its first witness. He'll ask questions of them, and you'll
- 20 have an opportunity to cross examine them.
- 21 Then the board will ask any questions of that witness.
- 22 Once he rests, you'll have an opportunity to put on your case.
- 23 He'll be able to cross examine you, and the board will also be
- 24 ask you questions.

- 1 Counsel, you may proceed when you're ready.
- 2 MR. THOMPSON: I'd like to make an opening statement.
- 3 MR. JACKSON: Okay, go ahead.
- 4 OPENING STATEMENT
- 5 MR. THOMPSON: CTAC members -- especially new members
- 6 -- this is a -- this is the first administrative hearing for
- 7 the new members.
- 8 This is going to be very straightforward. We brought this
- 9 to y'all to decide. The evidence will show that Ms. Parnell
- 10 at one time was practicing cosmetology without a license.
- 11 She was found in violation by the CTAC at the time -- 2019.
- 12 She was -- as part of her notice of hearing -- sorry. The
- 13 order from that time was you need to go ahead and get you a
- 14 license, and also pay a fine.
- The fine was rather large. It was the statutory limit of
- 16 \$1,000. The order also will show that it -- Ms. Kersey is
- 17 going to talk about, will state that the thousand dollars was
- 18 not paid, and that Ms. Parnell was to appear before y'all
- 19 before she was licensed.
- 20 So she does have an application pending before us. So we
- 21 decided to bring it before y'all for a decision.
- 22 And with that --
- 23 MR. JACKSON: Ms. Parnell, would you like to make an
- 24 opening statement?

- 1 OPENING STATEMENT
- MS. PARNELL: So I had received a letter just stating
- 3 that -- it was a warning letter, I guess, per se. And then I
- 4 stopped doing eyelashes at Jen's [phonetic spelling]. And
- 5 then I never heard anything else about it.
- 6 I thought that situation was just kind of done and over
- 7 with. And then I proceeded to go to school and get a license,
- 8 and I just want to practice cosmetology now that I have my
- 9 cosmetology license.
- 10 MR. JACKSON: Counsel, you may proceed with your
- 11 first witness.
- MR. THOMPSON: The department calls Kelli Kersey.
- MS. KERSEY: Kelli Kersey, Arkansas Department of
- 14 Health, Section Chief, Cosmetology, Massage Therapy and Body
- 15 Art.
- 16 [Kelli Kersey previously swore to tell the truth in these
- 17 proceedings.]
- 18 EXAMINATION OF KELLI KERSEY
- 19 BY MR. THOMPSON:
- 20 Q. And what do you do -- and Ms. Kersey, what do you do in
- 21 that role with ADH?
- 22 A. We oversee licensing and health and safety for all three
- 23 purposes.
- 24 Q. And are you familiar with the case before us today?

- 1 A. I am.
- 2 Q. And can you tell us how we got here today?
- 3 A. In 2019, we received -- February 13, 2019 we received a
- 4 complaint that Ms. Parnell was performing eyelash extensions.
- 5 And we investigated and found that it was on the Facebook page
- 6 that she was doing lash services.
- 7 We sent her a cease and desist letter on February 14 --
- 8 well, on February 16. February 21 we received another
- 9 complaint. The original complaint that stated that Ms.
- 10 Parnell repeated to conduct business and to advertise for lash
- 11 services.
- 12 On March 1, 2019, we received another complaint from the
- 13 official complainant that Ms.Parnell had continued that
- 14 business and to advertise for her services.
- March 13, we received another complaint. March 15 we sent
- 16 out a notice of hearing, certified and not certified. The
- 17 certified letter was returned to ADH as unclaimed, but not the
- 18 uncertified.
- 19 O. So the non-certified letter was not returned to us?
- 20 A. Correct. On July 22, 2019, the Cosmetology and
- 21 Technical Advisory Committee held a hearing and it was decided
- 22 that Ms. Parnell had to pay a thousand dollars and appear in
- 23 front of the committee -- back in front of the committee to
- 24 determine approval of licensure.

- 1 The original fine -- as of today the original fine has not
- 2 been paid. On 7-13-2023, ADH received Ms. Parnell's
- 3 certificate of training upon completion of cosmetology school.
- 4 So a decision was made to present this to the CTAC as an
- 5 administrative finding of fact, whether to require payment,
- 6 reduce or waive the original penalty, or deny or accept Ms.
- 7 Parnell's application for licensure with or without
- 8 conditions.
- 9 Q. So it's correct to say that ADH does not have a
- 10 recommendation today and this is for CTAC to decide whether to
- 11 enforce the fine, modify it, or totally not require the fine?
- 12 A. Correct.
- MR. THOMPSON: Okay, that's all I have.
- 14 MR. JACKSON: Okay. Ms.Parnell, do you have any
- 15 questions of this witness.
- MS. PARNELL: No.
- MR. JACKSON: Does the board have any questions for
- 18 this witness? Okay, no questions by the board.
- 19 Okay, counsel, may this witness stand down?
- MR. THOMPSON: Yes, Judge. Thank you.
- 21 MR. JACKSON: Do you have any other witnesses?
- MR. THOMPSON: I have no other witnesses, Judge.
- MR. JACKSON: Do you rest your case?
- MR. THOMPSON: I do, Judge.

- 1 MR. JACKSON: Okay. Ms. Parnell, here's your
- 2 opportunity to present your case.
- 3 TESTIMONY OF SASHA PARNELL
- 4 MS. PARNELL: So I originally had got I guess a
- 5 certification to do eyelash extensions. They were fairly new,
- 6 so I didn't realize that -- and I don't want it to be like I'm
- 7 playing dumb. But I really didn't realize that you had to
- 8 have a cosmetology to perform the eyelash extensions. And so
- 9 I didn't know.
- 10 And so I did eyelash extensions, got certified from the
- 11 girl that did my lashes. And just continued to advertise and
- 12 do all that stuff. I didn't realize that it was something
- 13 that was going to be an offense or something that I wasn't
- 14 allowed to do.
- I received a letter in the mail stating that I wasn't
- 16 allowed to do lashes. I immediately stopped doing them. The
- 17 business -- I think it was called Love Lash, or something
- 18 along those lines -- had made a post about me on Facebook.
- 19 And a whole bunch of people proceeded to comment on it, and
- 20 that's why there were numerous reports that were getting sent
- 21 in on multiple days after the fact, because of the amount of
- 22 traffic that this post had gotten, even though I was no longer
- 23 performing eyelash extensions after the warning letter.
- I tried to find some of those, but it probably had like 50

- 1 shares and like two to three hundred comments. So people kept
- 2 calling in acting like I was still doing lashes, and I had
- 3 completely stopped.
- I received the first letter, and then I moved. I'm
- 5 guessing that's why I never received the second letter saying
- 6 anything about how I was still doing them or a fine to pay, or
- 7 any of that.
- 8 Shortly after all of that stuff had happened, I just
- 9 continued on, didn't do anything cosmetology-related for
- 10 awhile. It's something I enjoy doing, so I went ahead and
- 11 applied and went to school, and got my license. And then I
- 12 tried to start working.
- I graduated from cosmetology school in July and tried to
- 14 pursue to work and get my license. It wasn't approved because
- 15 this -- there was still this thing I didn't know about.
- And so that's pretty much why I'm here today, just to
- 17 hopefully release my license so I can start working, because I
- 18 tried to make it right. But that's just really --
- 19 [inaudible]--
- 20 MR. JACKSON: Counsel, any cross-examination?
- 21 EXAMINATION OF MS. PARNELL
- 22 BY MR. THOMPSON:
- 23 Q. Ms. Parnell, you went to school and you got your
- 24 license.

- 1 A. Yes.
- 2 Q. So -- and so at this point it really is -- comes down to
- 3 -- comes down to that fine, the payment of that fine, correct?
- 4 A. Yes. I didn't even know about the fine. And I came up
- 5 to -- I guess it was to her office to pay the fine, and then
- 6 that's when I was given this letter stating that I needed to
- 7 come in front of you guys.
- 8 Q. So this -- so you're aware now that if you read the
- 9 order, regardless you had to come here and talk to them, even
- 10 if you had to pay the fine. That's why we're here today.
- 11 A. Yes.
- 12 Q. We're not -- you're here to tell your story, and for
- 13 them to decide. You understand that's why we're here today.
- 14 A. Yes sir.
- MR. THOMPSON: Okay, thank you. That's all I have.
- 16 MR. JACKSON: Do the members of the board have
- 17 questions for Ms. Parnell?
- MS.BOYDSTUN: Did you pay the fine?
- 19 MS. PARNELL: No. I tried to pay the fine. I was
- 20 given this letter saying you guys are supposed to decide.
- 21 MS.BOYDSTUN: And when did you move?
- MS. PARNELL: So I -- it was several years ago, but
- 23 it was in that time period. So maybe mid-September or October.
- 24 I'm actually not too sure.

- 1 MR. O'BAUGH: Are you still prepared to pay the fine
- 2 and have your license?
- 3 MS. PARNELL: If that's what you guys decide, then
- 4 yes.
- 5 MS. LANCE: Do you have somewhere to work at?
- 6 MS. PARNELL: Yes, I already have a job. They're
- 7 just waiting for my license to be released so I can start
- 8 working. It's going to be Elite Hair Salon in Russellville.
- 9 MS. MCGINNIS: I'm not sure how relevant this is, but
- 10 you said you took a course to be certified.
- 11 MS. PARNELL: Yes.
- MS. MCGINNIS: Was that from the state?
- MS. PARNELL: Yes ma'am.
- MS. MCGINNIS: Did you pay for that?
- MS. PARNELL: The girl that did my eyelash extensions
- 16 she was certifying other lash artists around northwest
- 17 Arkansas, and I don't know if that was legit or not, but I
- 18 didn't know anything about how the whole process worked.
- 19 And so I paid her \$275 to get certified to perform lashes.
- 20 And she just kind of taught me hands-on everything, and
- 21 provided me with a kit.
- MS. MCGINNIS: I was just curious.
- 23 MR. JACKSON: Do the members of the board who are
- 24 watching via Zoom have any questions.

- 1 MS. WARE: No.
- 2 MR. JACKSON: Is there any recross?
- 3 MR. THOMPSON: No recross, Judge.
- 4 MR. JACKSON: Do you have anything else you'd like to
- 5 add?
- 6 MS. PARNELL: No.
- 7 MR. JACKSON: Do you have any other witnesses you'd
- 8 like to call?
- 9 MS. PARNELL: No.
- MR. JACKSON: Do you rest your case at this time?
- 11 MS. PARNELL: Yes sir.
- MR. THOMPSON: Judge, I know we rested, but I think we
- 13 do have pertinent information from Mr. Hooper that we just
- 14 discussed. He is the branch chief over cosmetology and
- 15 massage therapy and he is Kelli Kersey's boss. And I'd like
- 16 for him to testify briefly.
- MR. JACKSON: Okay.
- 18 MR. THOMPSON: Based on her testimony. I think -- I
- 19 believe the respondent would probably not object when she
- 20 hears the testimony.
- 21 MR. JACKSON: Okay. At this time I'll allow for
- 22 rebuttal. Let me get this witness sworn in. If you could
- 23 identify yourself for the record, first.
- DR. HOOPER: Dr. Alex Hooper, branch manager,

- 1 Personal Care Services, overseeing cosmetology, massage
- 2 therapy and body art.
- 3 [Whereupon Alex Hooper swore to tell the truth in these
- 4 proceedings]
- 5 EXAMINATION OF ALEX HOOPER
- 6 BY MR. THOMPSON:
- 7 Q. Mr. Hooper, you've identified yourself for the record.
- 8 And so it's correct to say you're the branch chief and you're
- 9 Kelli Kersey's supervisor?
- 10 A. That's correct.
- 11 Q. And then in your experience as branch chief, we've -- we
- 12 do have people that have been acting -- ADH has people that
- 13 have been performing body art, cosmetology unlicensed,
- 14 correct?
- 15 A. Correct.
- 16 Q. Often people refuse to do what's required of them by the
- 17 law, correct?
- 18 A. At times, yes.
- 19 Q. At times that happens.
- 20 A. Yes.
- 21 Q. So and it's correct to say that so far, Ms. Parnell has
- 22 done everything, except for the thousand dollar fine, correct?
- 23 A. That's correct.
- 24 Q. Does the department have any recommendation on the

- 1 amount of that fine?
- 2 A. Yes. After reviewing the statements of fact and hearing
- 3 Ms. Parnell's testimony, the department will recommend that
- 4 CTAC either reduce the fine from \$1,000 to \$100 to cover
- 5 administrative costs, or waiver the fee entirely.
- 6 MR. THOMPSON: Thank you, Mr. Hooper.
- 7 MR. JACKSON: Do you have any cross examination of
- 8 the witness, given that that was I think entirely in your
- 9 favor?
- 10 MS. PARNELL: Thank you. No. I appreciate it.
- MR. JACKSON: Do members of the board have any
- 12 questions for the witness?
- 13 Counsel, anything else for the witness?
- MR. THOMPSON: Not for this witness.
- MR. JACKSON: Can he stand down?
- 16 MR. THOMPSON: Yes.
- MR. JACKSON: Does either party have anything else to
- 18 add? Closing?
- MR. THOMPSON: No, not anything before closing?
- MR. JACKSON: Okay. Counsel, you may proceed with
- 21 closing when ready.
- 22 CLOSING STATEMENT
- 23 MR. THOMPSON: So members of the board, you just heard
- 24 from Mr. Hooper. We have folks that absolutely just disregard

- 1 what the law and rules are when it comes to the statutes. And
- 2 sometimes we have to rely on sometimes criminal charges to
- 3 enforce that.
- 4 This individual, she did what she was supposed to do,
- 5 except for the fine. And we think that her owning up or
- 6 stopping doing the lashes, going to school, that's worth
- 7 something. And that shows a willingness to comply with the
- 8 law.
- 9 And so that's why since she's been here and we've heard
- 10 from her, that the department has a recommendation. But you
- 11 all don't have to take that recommendation. You all have the
- 12 power to impose the full fine, or do whatever you want short
- 13 of -- you know, the fine or lower.
- 14 So that's all I wanted to say.
- MR. JACKSON: Ms. Parnell, do you have a closing
- 16 statement?
- MS. PARNELL: I'm just trying to make everything
- 18 right, and start working so I can make some money. So --
- 19 MR. JACKSON: At this time we'll go off the record
- 20 for the committee to recess for deliberation and a decision
- 21 regarding finding of fact and conclusions of law.
- Once the board reaches a decision, we'll go back on the
- 23 record. So we're off the record at this time for y'all to
- 24 deliberate.

- 1 [Whereupon parties went off the record]
- 2 [Back on the record.]
- 3 MR. JACKSON: We're going to go back on the record in
- 4 this matter.
- 5 MS. BOYDSTUN: All right, so we're going to make a
- 6 motion that we're going to go with the finding of facts, and
- 7 change the amount of the original fee. It was a thousand
- 8 dollars, down to \$100 for administrative costs.
- 9 MS. LANCE: I second.
- MS. BOYDSTUN: All in favor.
- BODY: Aye.
- MS. BOYDSTUN: Opposed?
- BODY: [no response]
- MS. BOYDSTUN: Motion carries.
- MR. JACKSON: All right. Do you have anything else?
- MR. THOMPSON: No.
- MR. JACKSON: So just to confirm, you made a finding
- 18 of fact of true; however you're reducing the fine from \$1000
- 19 to \$100, and approving her license -- that was the motion?
- MS. BOYDSTUN: Yes.
- MR. JACKSON: And that was approved by everybody?
- MS. BOYDSTUN: Correct.
- 23 MR. JACKSON: Okay. Counsel, let the record reflect
- 24 that the board's decision was unanimous and if you could

- 1 reduce it to writing and serve it upon all parties. I've got
- 2 to say this because this is a part of it.
- 3 But if -- you probably won't avail yourself of an appeal.
- 4 But if you do care to appeal the decision, an appeal can be
- 5 taken under any specific provisions relating to the board or
- 6 the Administrative Procedures Act found in Arkansas Code
- 7 annotated 25-15-201, et seq.
- 8 And counsel, if you can include that as part of the notice
- 9 as well.
