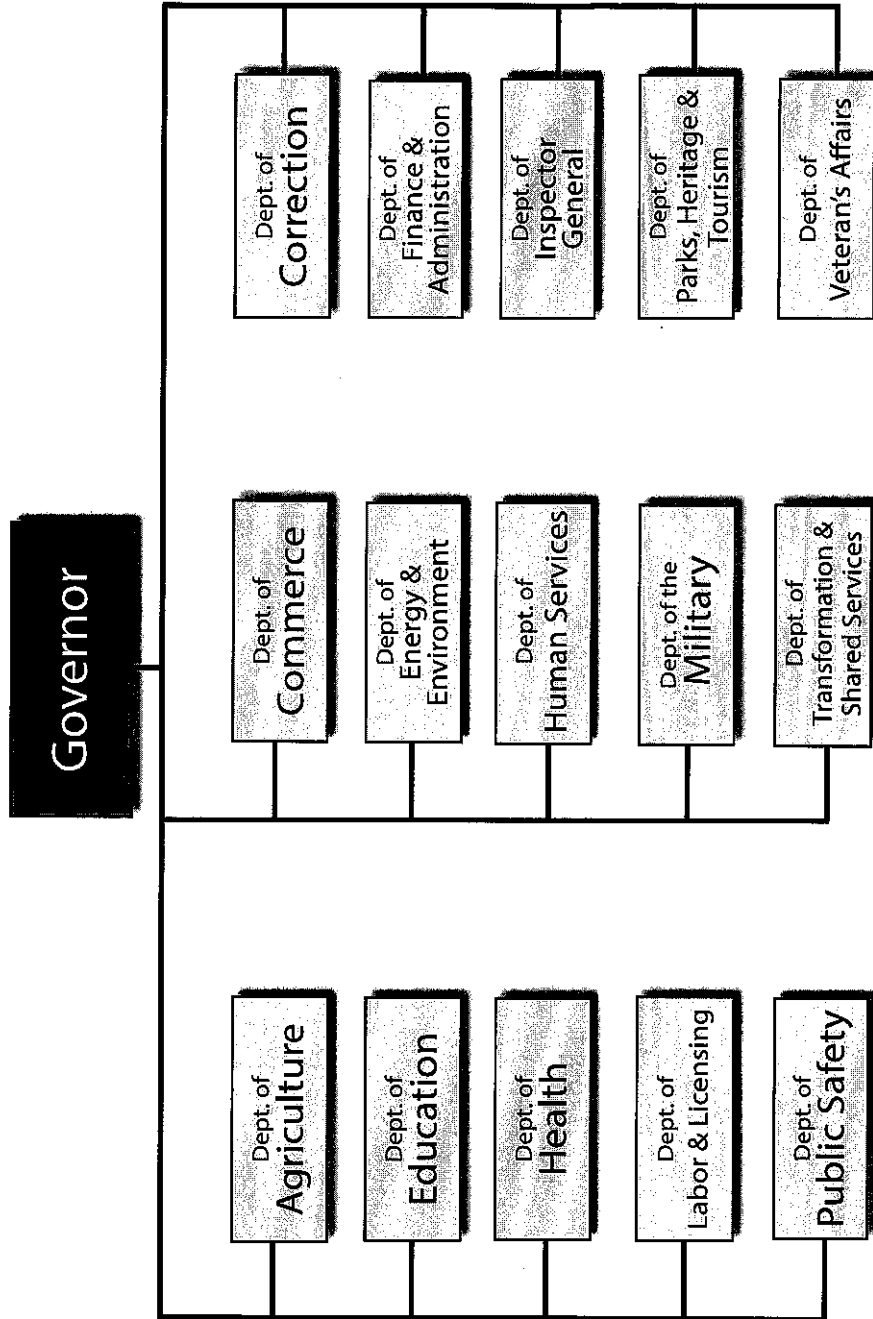

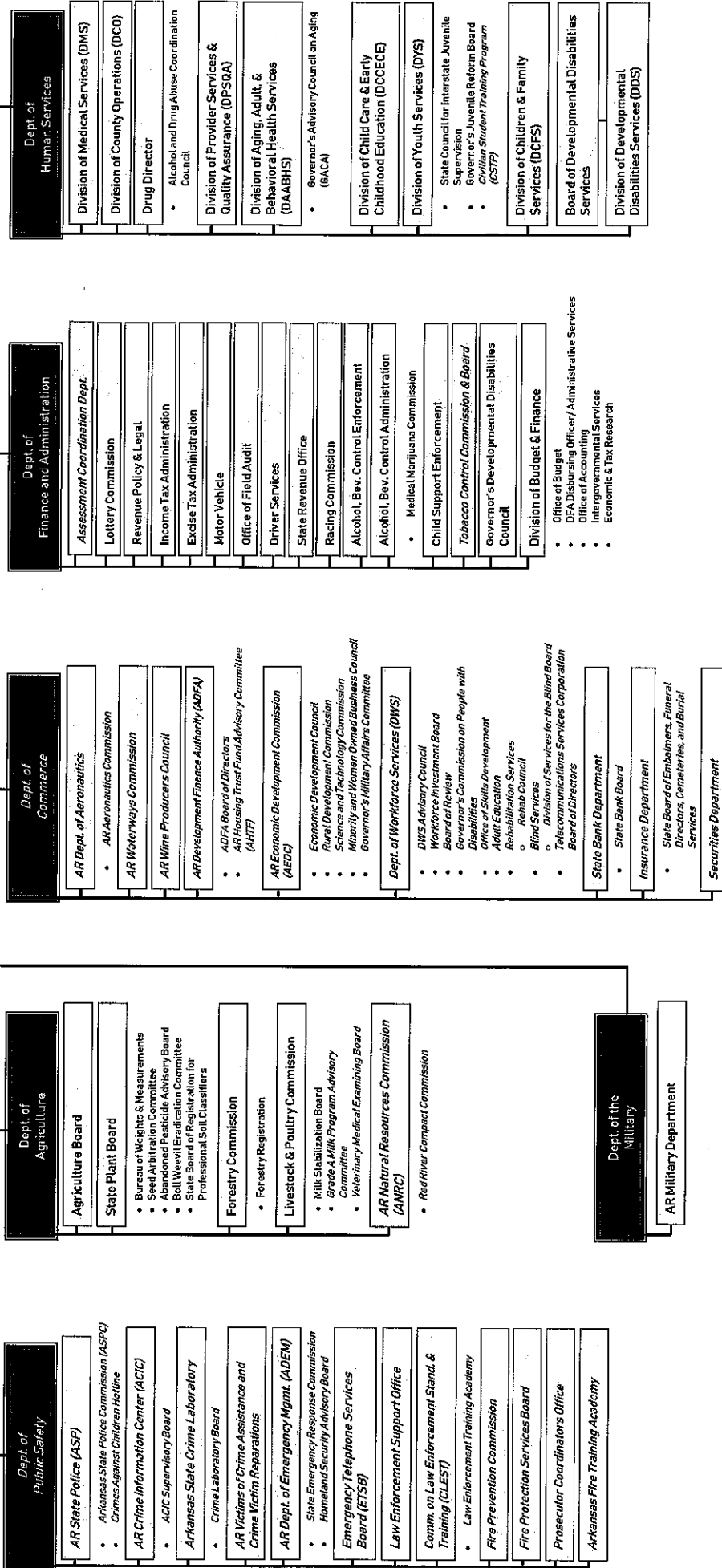

Arkansas Cabinet Level Agencies Proposed Restructure

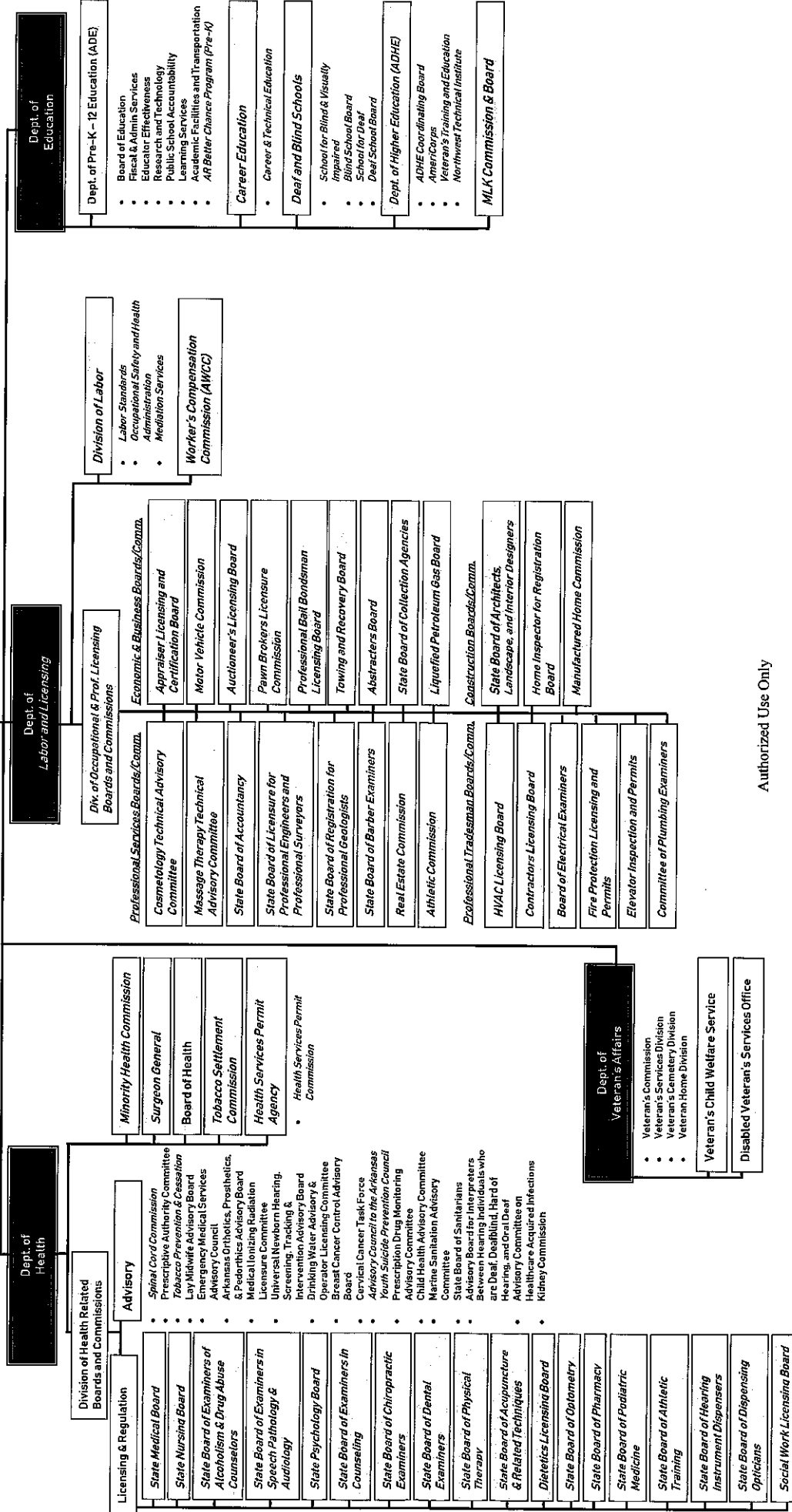


Governor Asa Hutchinson



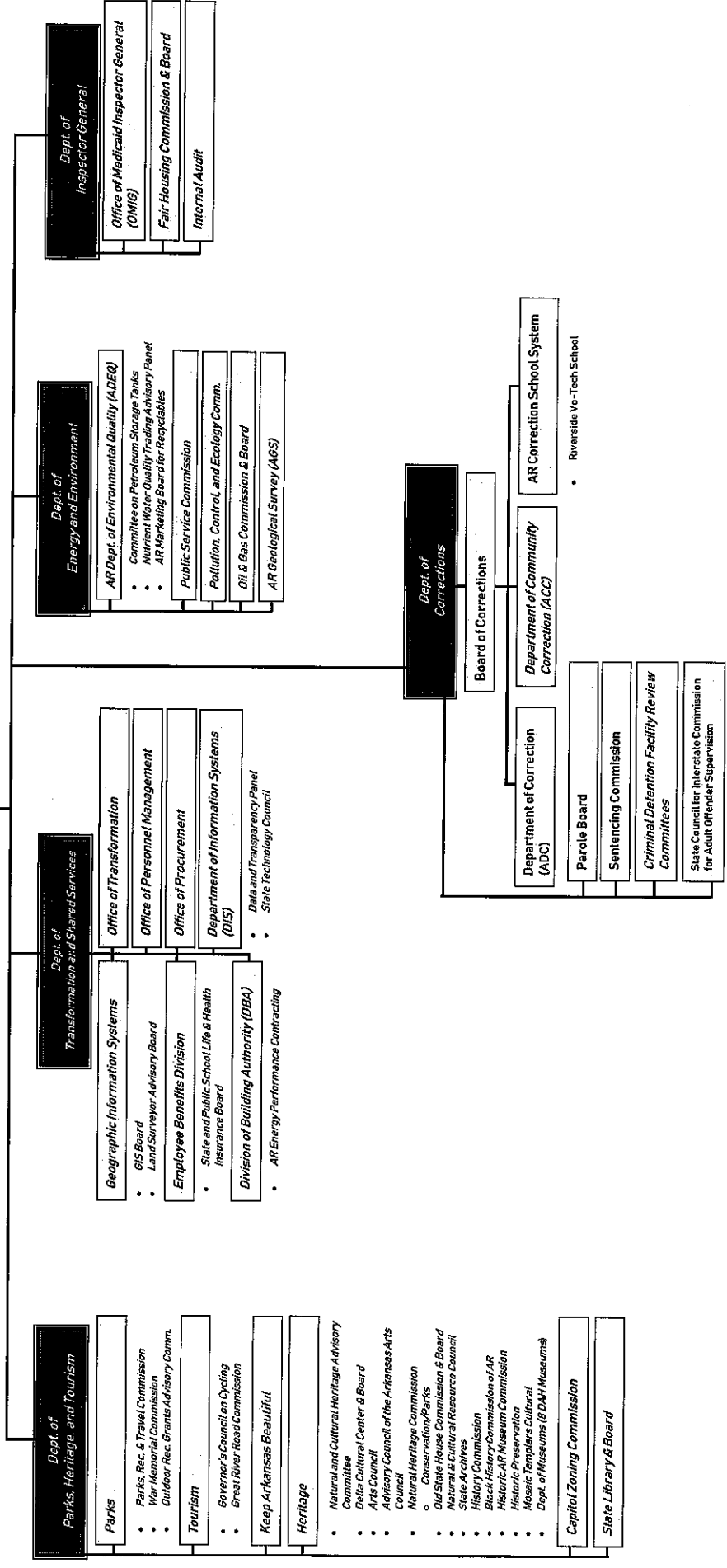

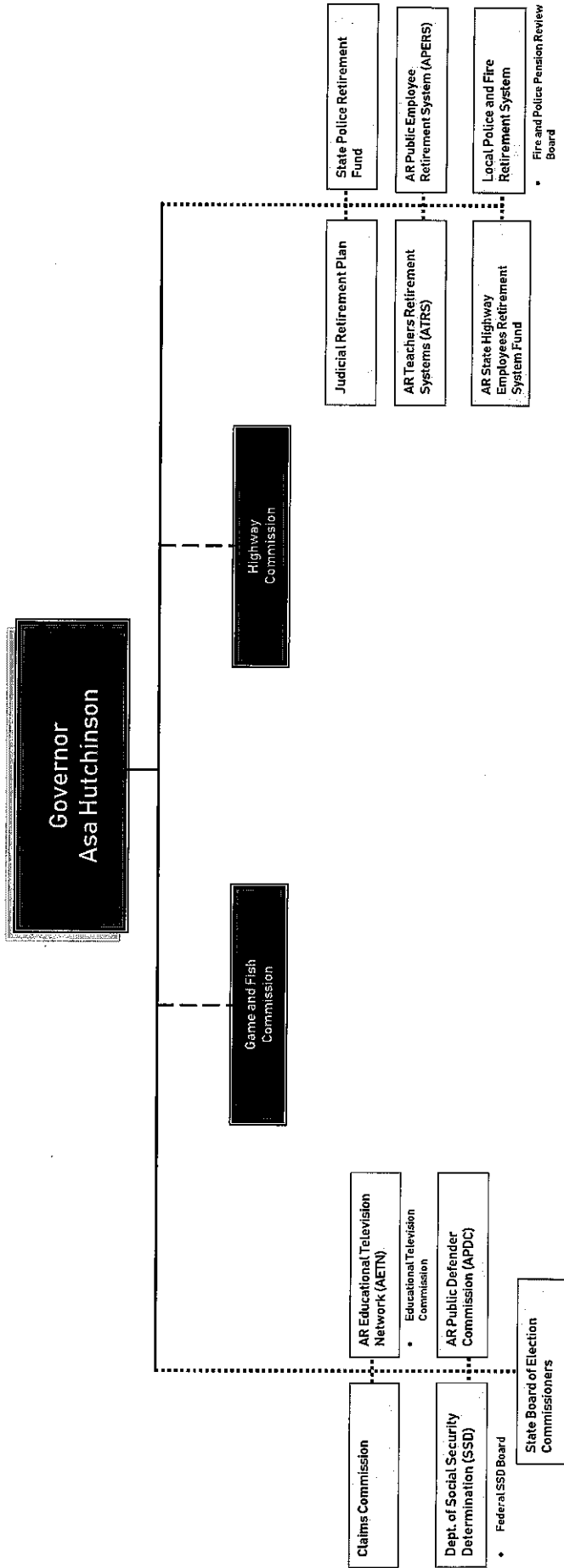

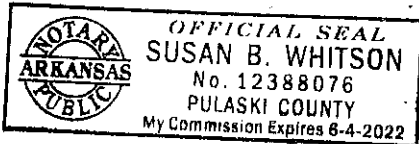
