Act 1220 Report

Out of the 993 schools that have submitted their Health and Wellness School Improvement Plan for review in Indistar, 473 have been accepted, 58 have been revised and are pending return to ADE, and 10 of them have been revised but need the final submission to be considered "accepted".

CSH Report

The final Quarterly Coordinated School Health meeting of 2021-2022 school year was held Wednesday, May 4, 2022, and supported 122 attendees from 74 school districts. Participants learned about teen dating violence and relationship skill building by Dr. Nan Stein, Wellesley College Center for Research on Women and Danielle Gray from the Ozark Rape Crisis Center. Old Business

Cristy Park: ADE Rules Governing Nutrition and Physical Activity Standards and Body Mass Index for Age Assessment Protocols in Arkansas Public Schools updates: C. Park provided a draft of suggest revisions that reflect recent legislation, terminology updates, organization name changes, and removing of federal requirements language. While adhering to the Federal Mandates is still required, the goal is to be consistent and have these rules language reflect Arkansas specific requirements. The next steps are for these to be taken to the State Board of Education where they will be approved for release for public comment; then the Governor's Office will be presented with these changes; then they will be posted for public comment. Cheria McDonald (Arkansas School Nurse Association): There have been 3 trainings "What's Poverty Got to do with It?". We are collecting stories already of those using the information they learned in this training to change practices.

Arkansas's poverty rate of 17.2% is the seventh highest in the US, only surpassed by Louisiana and Mississippi in the South. Kids Count data indicate that 24% of children in Arkansas live in poverty. The COVID-19 pandemic has worsened this issue, with many more children and families in the crisis of poverty than ever before.

School nurses see the impact of poverty on student health, firsthand. It affects students in a variety of ways. It can be seen via health issues stemming from food insecurity, poor housing, homelessness, or limited access to medical care for illnesses. Students who are living in the crisis of poverty have higher rates of hospital admissions, disability days, and death rates. There are 4.25 Contact Hours that will be provided. This nursing continuing professional development activity was approved by the Midwest Multistate Division, an accredited approver by the American Nurses Credentialing Center's Commission on Accreditation.
