Representative Lee Johnson provided information on the intent of the law to the committee and suggested to change the word "should" to "shall" in section 5 (b) (i). Darlene Byrd, DNP, APRN moved to accept this change and Mark Foster, DNP, APRN seconded the motion. The vote passed unanimously.

Leonie DeClerk, DNP, APRN stated that the hope is for the rules to be presented to the Legislative Committee in July and the committee may start reviewing applications as early as August 2022.
